





OVERVIEW





Note:

Calling indicator light: The 1st indicator light will activate if the call button is pressed.

Talking indicator light: The 2nd indicator light will activate if the call is picked up or the Door Station is being actively monitored.

Unlocking indicator light: The 3rd indicator light activates for 3 seconds when the door is unlocked.

Relay Outputs: Supports 2 relay outputs.

BASIC OPERATION

1. Onboarding

The current TWK system supports configurations of up to **two door stations** and three indoor monitors. The following instructions are based on this two-to-three setup. Similar configurations—such as one-to-two or two-to-two—can be completed by referring to the same steps with minor adjustments.

1.1. Language

Language is the first setting. We have 16 kinds of languages (Chinese Simplified, Chinese Traditional, English, Spanish, German, Polish, Russian, Turkish, Hebrew, Arabic, Portuguese, French, Italian, Slovak, Vietnamese, and Dutch) for customers to choose from.



1.2. Network Setting

Configure network settings for the first indoor monitor.



1.3. Indoor Monitor Mode

Please select "Main Indoor Monitor", this Indoor Monitor will be regarded as the main one.



1.4. Select Door Station

Door Station should be connected to the Indoor Monitor's when Indoor Monitor is searching Door Station.



Select Door Station and MAC of Door Station will appear. Click MAC of Door Station to Sync. Then the settings are completed.



1.5. Configure Door Station Settings

Set the basic parameters of the door station, including naming the device, registering the master card, and adjusting the call time and system volume according to the requirements.




 $TWK\ supports\ up\ to\ 2\ door\ stations\ and\ 3\ indoor\ monitors (multi-drop).$

When 2 door stations are involved, a DIN rail power supply and an inductor module are required. The wiring diagram is shown below.



1.8.1 Search the second door station in the main indoor monitor


2. You can answer, reject, open the door, or speak with the visitor.



3. IP Cameras Monitoring

- 3.1 IP cameras monitoring
 - 1. Connect the Ethernet cable to both IP Camera and Indoor Monitor. Please keep them under the same LAN.
- 2. Add IP Camera to the Indoor Monitor on the device:
- Step 1: You can click Cameras to enter the page about IP cameras.
- Step 2: Name IP camera and type in URL after clicking "+" icon.URL contains the Name and RTSP URL. Make sure the URL of the IP Camera is right. Please get your IPC RTSP stream URL from Internet or IPC provider.







The followings are introductions about the buttons to control monitoring of cameras:

The name of IP Camera is on the top for switching the cameras.



4. DND

4 Doors

4.1. Upgarde and Reset

You can upgrade and reset Door Station on this page by clicking the arrow icon (Upgrade) and circle icon (Reset).

Upgrade method: Put the FW on a folder named "doorUpgrade" on TF card, then click arrow icon here.





4.2. Manage other cards by admin card

- a) Add Master card: Tap your card on Indoor monitor after you click"Read", this card is your Master card.
- b) Add cards for lock 1: Tap your Master card once and then tap user cards immediately. If you have multiple user cards to add, you can tap them one by one. And tap Master card again to finish.

- c) Add cards for lock2: Tap your Master card twice and then tap user cards immediately, if you have multiple user cards to add, you can tap them one by one, and tap Master card again to finish
- d) Delete other cards one by one: Tap your Master card four times and then tap user card immediately. The card you have tapped will be deleted. Tap Master card again to finish.
- e) Delete all other cards: Tap your Master card five times. All the other cards will be deleted.

Please note that Master card can only be used to manage cards. It cannot be used to open the door.

If you want to edit the Door station information, you need to enter the password, the default password is' 123456'.







5. System

5.1. Version

You can upgrade and Indoor Monitor on this page.

Upgrade method: Put the FW on a folder named "Upgrade" on TF card, then click Upgrade here.

And there is information about Indoor Monitor, including IP address, MAC address and TF card.


5.2.1. Download Smart Life app

5.2.2. Register, log in



3. On the Enter Verification Code page, enter the verification code. On the Set Password page, set the password as per instructions and tap Done.





5.2.3. Scan QR code

- $1. \ License \ of \ Smart \ Life \ app \ will \ be \ filled \ in \ Indoor \ Monitor \ before \ delivery.$
- Step 1: Go to Settings > System page.
- Step 2: Select the QR code.
- Step 3: Scan QR code. One QR code can only be bound to one phone but resident can share resident's authority to its family members up to 20 users.



- 2. Congratulations. Door Station is successfully connected to resident's phone.
- 3. After you complete the above steps, the Smart Life app will automatically enter the interface of monitor. You can make a video call to Door Station and unlock remotely on the smart phone. If Door Station is calling in, Indoor Monitor and Smart Life App can ring at the same time, and the mobile phone APP can answer the call and unlock remotely. Smart Life App can also monitor and unlock Door Station.






a) Rename devices

Step 5: Rename device.




b) Share devices




1. Power

Power interface of Indoor Monitor connects with 24V 2-wire adapter.




2. Switching Value Output (S212-2)

Connect to the lock module (an independent power supply is necessary for the lock).











Tips:

TROUBLESHOOTING

The Indoor Monitor cannot start up or power off automatically.

• Check whether it has power-failure, and power it on again

The Indoor Monitor display screen is too dim.

• Check whether the brightness and contrast settings of screen are correct.

No sound during the communication.

 Check whether the Indoor Monitor is set as mute mode, or the volume is set to the lowest

The Indoor Monitor cannot monitor the Door Station.

 Other user is using the system, so you can use it once he/she finished the operation.

Multimedia files cannot be played normally.

 Check whether the system supports the file format. Please refer to the multimedia setting for details.

No response when clicking Indoor Monitor display screen.

Press "Unlock" button for 5s, or slowly slide horizontally or vertically on the
 LCD to make touchscreen calibration. It needs to be calibrated.

Touchscreen responses slowly or cannot make calibration.

- Take down any protective paster, since it may affect identification
- and input for device;
- Ensure the finger is dry and clean when clicking touchscreen;
- Restart the device to clear any temporary software error.

The temperature of device is too high.

 Long-term use leads to high temperature. It's normal and will not affect the device's use life and performance.

SAFETY INSTRUCTION
